

# Privacy Notice

## St Eanswythe's Church of England Primary School



### Learning holistically through God's unconditional love.

This notice explains what personal data (information) we hold about you, how we collect, how we use and may share information about you. We are required to give you this information under data protection law.

St Eanswythe's Church of England Primary School collects, uses and is responsible for certain personal information about you. When we do so we are regulated under the General Data Protection Regulation which applies across the European Union (including in the United Kingdom) and we are responsible as 'controller' of that personal information for the purposes of those laws. Our Data Protection Officer is Angela Woodgate

#### The personal information we collect and use

##### Information collected by us

In the course of providing education we collect the following personal information when you provide it to us:

1. Personal information (such as name, unique pupil number, contact details language, nationality, country of birth, and free school meal eligibility)
2. Special category characteristics
3. Ethnicity
4. Special educational needs (SEN) information
5. Relevant medical information
6. Attendance information (such as sessions attended, absences and absence reasons)
7. National curriculum assessment results

##### We also obtain personal information from other sources as follows:

1. Personal information, special category information, assessment results and
2. SEN information from schools that you previously attended
3. Service support and involvement information from KCC teams working to improve outcomes for children and young people (such as SEND, Early Help,
4. Free School Meals, Admissions)

#### How we use your personal information

##### We use your personal information to:

- a. Support pupil learning
- b. Monitor and report on pupil progress
- c. Moderate teacher assessment judgements
- d. Provide appropriate pastoral care and support services
- e. Assess the quality of our services
- f. Comply with the law regarding data sharing
- g. Support you to decide what to do after you leave school
- h. Support or improve educational provision
- i. Ensure no children are missing education
- j. Support children at risk of permanent exclusion

- k. Support the primary, secondary and in-year admissions process
- l. Safeguard children and young people
- m. Improve the education and services we provide

### How will we keep your personal data?

We will hold your personal information securely and retain it from the child's entry until they no longer attend our school, after which the information is archived, passed on or securely destroyed.

### Reasons we can collect and use your personal information

We collect and use pupil information under section 537A of the Education Act 1996, section 83 of the Children Act 1989, and to carry out tasks in the public interest. If we need to collect special category (sensitive) personal information, we rely upon reasons of substantial public interest (equality of opportunity or treatment).

If there is processing or sharing that relies on your consent, we will make this clear to you and ensure we seek your consent.

Who we share your personal information with

1. Department for Education (DfE) (statutory for school funding and educational attainment policy and monitoring) and other government agencies and local authorities as required (e.g. to resolve funding queries)
2. Kent County Council teams working to improve outcomes for children and young people
3. Schools or colleges that you attend after leaving us
4. Local forums with schools and KCC representatives which support in-year fair access processes and support managed moves between schools
5. Local multi-agency forums which provide SEND advice, support and guidance (such as Local Inclusion Forum Team (LIFT))
6. Partner organisations signed up to the Kent & Medway Information Sharing Agreement, where necessary, which may include Police, school nurses, doctors and mental health workers and Kent Community Health NHS Foundation Trust
7. Schools in our local collaboration, to enable the moderation of pupil assessment outcomes, to support collaborative working through joint analysis, and ensure children continue to receive appropriate education provision
8. St Eanswythe's Primary School has to share information with external moderators (teachers with recent relevant experience) of end of key stage assessments, to meet statutory requirements from the Standards & Testing Agency (STA)
9. P. Hembley Photography to provide parents with pupil photographs each year and pupil images for our Management Information System
10. GL Assessment who provide CATs and other assessment tests and may require pupil information to ensure results are properly standardised
11. Tapestry – to share images and information about children's learning in YearR with parents through their secure, UK hosted, online platform
12. CPOMS – who hold safeguarding information on a secure system to allow staff to share concerns and incidents efficiently
13. We will share personal information with law enforcement or other authorities if required by applicable law.

We are required to share information about our pupils with KCC and the Department for Education (DfE) under section 3 of The Education (Information About Individual Pupils) (England) Regulations 2013.

St Eanswythe's Primary School has a legal responsibility with KCC to track all young people up to the age of 19 (and young adults with learning difficulties or disabilities up to the age of 25). The purpose of collecting this information is to assist the planning of education and training for young people and the support services they require. This is in relation to education, training, employment with training you may be undertaking and whether you are NEET (not in Education, Employment

or Training). Some of this information is then shared with the DfE who use the information to plan at a national level.

This information enables KCC to provide and arrange:

- a. post-16 education and training provision
- b. youth support services
- c. careers advice and guidance

### The National Pupil Database (NPD)

The NPD is owned and managed by the DfE and contains information about pupils in schools in England. It provides invaluable evidence on educational performance to inform independent research, as well as studies commissioned by the DfE. It is held in electronic format for statistical purposes. This information is securely collected from a range of sources including schools, local authorities and awarding bodies.

We are required by law, to provide information about our pupils to the DfE as part of statutory data collections such as the school census and early years' census. Some of this information is then stored in the NPD. The law that allows this is the Education (Information About Individual Pupils) (England) Regulations 2013.

The DfE may share information about our pupils from the NPD with third parties who promote the education or well-being of children in England by:

1. conducting research or analysis
2. producing statistics
3. providing information, advice or guidance

The DfE has robust processes in place to ensure the confidentiality of our data is maintained and there are stringent controls in place regarding access and use of the data. Decisions on whether DfE releases data to third parties are subject to a strict approval process and based on a detailed assessment of:

1. who is requesting the data
2. the purpose for which it is required
3. the level and sensitivity of data requested: and
4. the arrangements in place to store and handle the data

To be granted access to pupil information, organisations must comply with strict terms and conditions covering the confidentiality and handling of the data, security arrangements and retention and use of the data.

### Your Rights

Under the GDPR you have rights which you can exercise free of charge which allow you to:

1. Know what we are doing with your information and why we are doing it
2. Ask to see what information we hold about you (Subject Access Requests)
3. Ask us to correct any mistakes in the information we hold about you
4. Object to direct marketing
5. Make a complaint to the Information Commissioners Office
6. Withdraw consent (if applicable)

Depending on our reason for using your information you may also be entitled to:

1. Ask us to delete information we hold about you
2. Have your information transferred electronically to yourself or to another organisation
3. Object to decisions being made that significantly affect you
4. Object to how we are using your information
5. Stop us using your information in certain ways

We will always seek to comply with your request however we may be required to hold or use your information to comply with legal duties. Please note: your request may delay or prevent us delivering a service to you.

### Keeping your personal information secure

We have appropriate security measures in place to prevent personal information from being accidentally lost, or used or accessed in an unauthorised way. We limit access to your personal information to those who have a genuine business need to know it.

Those processing your information will do so only in an authorised manner and are subject to a duty of confidentiality.

We also have procedures in place to deal with any suspected data security breach.

We will notify you and any applicable regulator of a suspected data security breach where we are legally required to do so.
